Staff Introduction

Joan McDermott

Joan McDermott was born in Wisconsin and grew up on a dairy farm. She attended Walther Memorial Hospital School of Nursing in Chicago and later earned a Bachelor of Science degree at Washburn University in Topeka. Joan was commissioned as a First Lieutenant in the U.S. Army Nurse Corps in 1967. She served two tours of duty in Vietnam. She arrived in Saigon 1 month before the Tet Offensive in 1968 and was in Phu Bai in 1971. Between those tours, she was assigned to Walter Reed National Military Medical Center. Her most memorable surgical patient was President Dwight D. Eisenhower. After active duty, Joan was employed in a variety of staff and supervisory nursing roles.

Joan married an active duty Army officer and fellow Vietnam veteran in 1974. She attended familiarization and language classes in preparation for international diplomatic assignments where she proudly represented her country in Australia, The Philippines, Singapore, and Malaysia for 11 years. Joan was active in many volunteer organizations and activities. She was a tour guide at the historic Custer House in Fort Riley, Kansas, supported foreign officers and families, civilian orphanages, international school programs, the Girl and Boy Scouts of America, and was a hospice volunteer. She co-founded support groups for parents with children who had learning disabilities in two Southeast Asian countries.

She has 3 children and 6 grandchildren. Her eldest son served 3 tours of duty, after the September 11, 2001 attack, in Iraq and 2 tours in Afghanistan as a U.S. Army officer.

Since moving to Lake Havasu City, Arizona, Joan has been active as an officer in the Veterans of Foreign Wars and the Military Officers Association of America. She is a member of the Vietnam Veterans of America, the American Legion, Stonebridge Veterans, the Elks, and Eagles. She works at local veteran stand-downs, is a member of two Western Arizona Council of Governments (WACOG) boards, is a volunteer Medicare counselor, is a new United Arizona Veterans board member, and is an inaugural member of the Havasu Veterans' Resource Team. She is a 2016 inductee into the Arizona Veterans' Hall of Fame. Joan finds it a privilege to be able to learn about helping services locally and across Arizona through these associations, as she can help to guide veterans and others to the helping services they need.

Serving as the mentor coordinator for the Lake Havasu City Veterans Treatment Court since shortly after its inception 10 years ago has been her most passionate commitment. She says that it has been a humbling experience to be part of the team that has become a national leader with a program that targets the needs of justice-involved veterans and demonstrates that we never give up on any of them. She sees the commitment, the right multidisciplinary components, and the willingness of the team to consistently work together to improve as the winning components of the program. There is no greater reward than to know that program graduates are now proud, successful members of our community.


VTC Lake Havasu vs. Kingman

This Month in U.S. Military History

Memorial Day

"The Civil War claimed more lives than any conflict in U.S. history, requiring the establishment of the country's first national cemeteries. By the late 1860s Americans in various towns and cities had begun holding springtime tributes to these countless fallen soldiers, decorating their graves with flowers and reciting prayers.

"It is unclear where exactly this tradition originated; numerous different communities may have independently initiated the memorial gatherings. Nevertheless, in 1966 the federal government declared Waterloo, New York, the official birthplace of Memorial Day. Waterloo—which had first celebrated the day on May 5, 1866—was chosen because it hosted an annual, community-wide event, during which businesses closed and residents decorated the graves of soldiers with flowers and flags.

"On May 5, 1862, General John A. Logan, leader of an organization for Northern Civil War veterans, called for a nationwide day of remembrance later that month."



"The date of Decoration Day, as he called it, was chosen because it wasn't the anniversary of any particular battle.

"Memorial Day, as Decoration Day gradually came to be known, originally honored only those lost while fighting in the Civil War. But during World War I the United States found itself embroiled in another major conflict, and the holiday evolved to commemorate American military personnel who died in all wars.

"For decades, Memorial Day continued to be observed on May 30, the date Logan had selected for the first Decoration Day. But in 1968 Congress passed the Uniform Monday Holiday Act, which established Memorial Day as the last Monday in May in order to create a three-day weekend for federal employees; the change went into effect in 1971. The same law also declared Memorial Day a federal holiday."
