

RESOLUTION NO. 24-3725

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, ORDERING AND CALLING A PRIMARY ELECTION TO BE HELD ON TUESDAY, JULY 30, 2024, AND, IF NECESSARY, A GENERAL ELECTION ON TUESDAY, NOVEMBER 5, 2024, TO NOMINATE CANDIDATES FOR COUNCILMEMBER POSITIONS; AND PROVIDING FOR AND GIVING NOTICE OF SUCH ELECTIONS AND THE DEADLINE FOR VOTER REGISTRATION; AND THE PLACE AND LAST DATE FOR CANDIDATES TO FILE NOMINATION PAPERS

IT IS RESOLVED, by the Mayor and City Council of Lake Havasu City, Arizona, as follows:

Section 1. Order and Call of Election; Purpose

The Primary Election is hereby ordered and called to be held in and for Lake Havasu City on Tuesday, July 30, 2024, for the purpose of nominating candidates for three councilmember positions and November 5, 2024, is set as the time for holding the General Election in Lake Havasu City. Any candidates receiving a majority of all the votes cast at the Primary Election will be declared elected without running in the General Election.

Section 2. Publication of the Call and Notice of Election

The publication of the call and notice of the Election shall be given, or caused to be given, by the City Clerk, as provided by law, and as may be deemed necessary and appropriate in the City Clerk's discretion to advise the public of the Election.

Section 3. Designating Deadline for Voter Registration

Mohave County registration and voting lists will be used for the municipal election. To be qualified to vote in the Primary Election, a City resident must be registered to vote by Monday, July 1, 2024. To be qualified to vote in the General Election, a City resident must be registered to vote by Monday, October 7, 2024.

Section 4. Deadline to File Candidate Nomination Form

Candidates seeking municipal office may obtain nomination papers and other required materials, which must be filed by candidates in the City Clerk's Office at City Hall, 2330 McCulloch Boulevard North, Lake Havasu City, Arizona, 86403, by the deadline of 5:00 p.m. on April 1, 2024, in order for their names to appear on the Primary Election ballot.

Section 5. Canvass of Election

The returns of the Election shall be made to the Council who shall meet pursuant to law after the election to canvass the returns of the election and certify the results, all as provided by law. The Council will be governed by the vote of the majority on the questions submitted.




