### **8. Airport Supervisor Report**

- February-March 2015: Air tractors airborne firefighting equipment training on site. They have informed Airport Operations that they will be back for next year's training.
- Site 4 hangar project materials have been delivered. Building permits are being reviewed by the Building Dept. The earthwork has been completed.
- Wings, Wheels & Wave / Big Boy Toys 2015 review: up to 10,000 attendees, 70 vendors and an estimate of \$183,000 economic impact, 12 war bird rides by the Commemorative Air Force, plus various tours of the aircrafts. Plans for the 2016 event are underway.

### **9. Discussion Items & Possible Action**

#### **a. RFP Engineering & Planning for Airport** – *discussion*

The airport has two state grants that will be sent to City Council for approval; one grant will be amended to increase the amount by \$250,000. \$547,000 will be received from ADOT for runway improvements, drainage & FOD improvements, and fire hydrant relocation.

We have also been informed by the FAA that we have around \$450,000 in entitlement grants funds that have been banked for project use. Staff will be working on an RFP process for engineering consultants and planning consultants.

#### **b. RFP –North Ramp Hangars** – *review & report on project*

This process is on hold at this time.

#### **c. FAA/ADOT ACIP** - *discussion*

ADOT/FAA will be holding their ACIP review meeting in Phoenix this year. The board was given a handout listing the ACIPs that will be given to ADOT/FAA at the meeting.

There was between 165-183 attendees at the 5-day AzAA Conference event: there was about \$90,000 economic impact as a result from this conference.
