

ORDINANCE NO. 26-1379

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, AMENDING LAKE HAVASU CITY CODE SECTION 3.20.040, SCHEDULE OF FEES AND SERVICE CHARGES, TO ADD AND REVISE FEES AND SERVICE CHARGES FOR PAVEMENT RESTORATION, UTILITY PERMITS, AND SPECIAL EVENTS (POLICE AND FIRE SERVICES AND STREET CLOSURES)

IT IS ORDAINED by the Mayor and City Council of Lake Havasu City, Arizona, as follows:

Section 1: The table contained in City Code Section 3.20.040, Schedule of Fees and Service Charges, is amended to add or revise Service Center Numbers: S-036, S-038, and S-122 as follows:


