The system displayed the "Due Date" as 4:00 p.m. Arizona time (as shown in the screen capture below), which created confusion for bidders and also prevented submittals from being uploaded.</p> <p>Due Date 08/27/2025 4:00 PM Arizona</p> <p>Upon becoming aware of this issue, the City conducted a thorough review and confirmed that the time discrepancy within the DemandStar e-procurement system affected the submission process. To ensure fairness and equal opportunity for all participants, the City has corrected this technical issue and extended the electronic submittal deadline by an additional forty-eight (48) hours. Design-Builders are now able to successfully upload their submissions under the amended deadline.</p>
