

INVITATION TO BID ITP METAL STORAGE BUILDING CONSTRUCTION PROJECT B25-PW-107024-500558 ADDENDUM NO. 1 SEPTEMBER 6, 2024

Attention is called to the following changes, additions, clarifications and/or deletions to the original solicitation and they shall be considered in preparing submissions:

There is no change in the opening date. **Submissions are due no later than 3:00 p.m., Arizona Time, SEPTEMBER 11, 2024**, at the City Clerk's Office, 2330 McCulloch Blvd. N., Lake Havasu City, AZ 86403.

ITEM ONE (1): QUESTIONS AND ANSWERS

The following questions were received at the pre-bid meeting held August 27, 2024 @ 9:00AM.

1. Question: How much time should be allowed for City building inspections?

Answer: LH Building department will typically inspect within 48hrs, 2 business days after scheduled.

2. Question: Do the City have any "Buy American" or "Prevailing Wages" stipulations?

Answer: No

3. Question: Who is responsible for the cost of building permit and inspections?

Answer: 1. The cost of building permit and LH inspections are "0 cost/ no charge."

2. There will be "Special inspections," These will have to be scheduled with a private inspection company and are "at the expense of the contractor."

4. Question: Does this building have an insulation package to install?

Answer: There is no insulation to install.

5. Question: Asphalt demo and site work required?

Answer: The existing asphalt will have to be removed by the contractor. There is existing asphalt in the proposed area of the new steel building. LHC will accept concrete or asphalt patch back, as required, patch back to the new building's concrete foundation.

6. Question: Where are the building's fasteners? They were not available to view at time of project's pre bid walk.

Answer: After the pre bid site walk, LHC opened up the palletized material and located the fasteners and hardware, these are provided by LHC. The Anchor bolts and foundation hardware to be furnished by the contractor.

7. Question: Who is responsible to provide missing building components and related fasteners?

Answer: Contractor to inventory components and hardware within 7 days of construction start. If it is determined there are any missing components, Provide LHC with an RFI. LHC will provide a change order to cover cost of missing components.

ITEM TWO (2): REVISED BID SCHEDULE

The original Bid Schedule was missing the dollar amount for the Force Account. A revised Bid Schedule has been provided (See Attachment A).

ITEM THREE (3): ATTENDANCE
