On page WT02 at the first tee specs out a 8"x4" tee but then asks to connect a 6" line to that 8" x 4" tee. I assume you want a 4" line as it's connecting to an existing 4" line.

In regards to sheet WT02, The water line lateral located at Station 212+56.77 should consist of 4" PVC C900 DR 14. The 8"x4" tee called out is correct. Please remove Water Note 15 from station 212+56.77.
