## ADDITION TO SECTION H - TECHNICAL SPECIFICATIONS:

## 1. GENERAL

All base materials consisting of appropriately sized coarse and fine aggregates (**excluding** Reclaimed Concrete Material (RCM) and Reclaimed Asphalt Pavement (RAP)) used for aggregate shall be in accordance with the specifications and requirements of Sections 701(Aggregate) & 702 (Base Materials), of the Uniform Standard Specifications for Public Works Construction sponsored and distributed by the Maricopa Association of Governments (MAG), and referenced sections of the American Society for Testing Materials (ASTM).

Weighing and metering devices used for the purpose of proportioning materials shall fulfill requirements as to the accuracy and tolerance prescribed by the Weights and Measures Division of the State of Arizona and shall be sealed and certified in accordance with procedures established by this agency. This certification shall not be over 12 months old and shall be renewed whenever required by the engineer.

## ITEM TWO (2): QUESTIONS AND ANSWERS

**Question 1:** Please supply bid results from the last time this project was bid.

**Question 2:** Will the aggregate be used by the City to self-perform projects? Or will the City be supplying the material and contractors will be bidding labor & equipment on future bids?

Answer 2: Aggregate will be used by the City to self-perform projects. Future bidding methodology is internally assessed to arrive at, in its sole discretion, a determination considered to be in the best interest of the City.

**Question 3:** Have any substitutions been approved for this project?

Answer 3: No substitutes have been requested at this time.

**Question 4:** As this contract is a 1 year with 4 optional 1 year extensions, can you confirm if these extensions are at the sole discretion of the City? Or mutual agreement between the supplier and City?

Answer 4: Renewal options are based on mutual agreement between the supplier and the City.
