#### **SUBJECT:**

Award Bid for Asphalt Repairs and Concrete Valve Collars in Four (4) Various Locations to Cactus Asphalt (Kenneth Porosky)

#### **FUNDING SOURCE:**

Water Utility Fund HURF Fund

#### **PURPOSE:**

Award bid to replace existing asphalt roadway and concrete valve collars in four (4) locations due to Water Main Breaks and deteriorating asphalt.

#### **BACKGROUND:**

The Lake Havasu City Public Works Department solicited bids for replacing the existing buckled asphalt roadways at three locations due to water main breaks. Also includes a section of deteriorating asphalt near the intersection of Lake Havasu Avenue and Papago Drive. Approximately 1,915 square yards of existing asphalt will be removed and replaced with hot mix asphalt. Cost of City supplied/funded asphalt is approximately \$40,000.

245 London Bridge Road – 520 Square Yards Thunderbolt Ave at Arapaho Dr – 450 Square Yards Mesquite Ave between Lake Havasu Ave & US95 – 435 Square Yards Lake Havasu Ave at Papago Dr – 510 Square Yards

Two bids were received for this work, ranging from the low bid from Cactus Asphalt of \$70,503.49 to the high of \$116,466.92.

#### **COMMUNITY IMPACT:**

This work will complete the necessary pavement repairs in the area and provide a smoother, safer roadway for the traveling public.

#### **FISCAL IMPACT:**

Appropriations are available in the Water Department for Fiscal Year 2019-20 in the amount of \$52,877.62 (231-7420-52220) and HURF Fund Fiscal Year 2019-20 in the amount of \$17,625.87 (221-5110-403-52220)
