SUBJECT:

Ratify the Bid Award for Bulk Supply of Ferric Chloride for Drinking Water Treatment to Kemira Water Solutions (*J. Greg Froslie*)

FUNDING SOURCE:

Irrigation and Drainage District Fund

PURPOSE:

To ratify the Bid Award for Bulk Supply of Ferric Chloride in accordance with City Code Section § 3.10.030.1.5 (ITB No. B20-WTR-500049).

BACKGROUND:

On March 4, 2020, sealed bids were received and opened for the bulk supply of Ferric Chloride used for treating Lake Havasu City's potable water supply. Bid notices were sent to potential bidders as well as advertised by the local newspaper and uploaded on both the Lake Havasu City and Onvia DemandStar websites.

Three (3) bids were received in response. The three responsive bidders were:

Kemira Water Solutions \$50,112.00 Thatcher Company of Arizona \$52,800.00 Pencco, Inc. \$62,720.00

COMMUNITY IMPACT:

Purchased materials will be used at the Water Treatment Plant, which is a state-of-art technology water treatment plant facility designed to improve the quality of the City's drinking water by utilizing new technology which eliminates manganese and also lowers levels of other inorganic substances that naturally occur in water. Ferric Chloride in bulk quantities is used for treating the City's potable water supply.

FISCAL IMPACT:

Appropriations are available in the amount of \$50,112 in the Irrigation and Drainage District Fund.
