Award Bid for the Mulberry Wastewater Treatment Plant Aeration Basin, Structural and Motor Control Center Upgrades Project to Kinney Construction, LLC (*Jason Hart*)

FUNDING SOURCE:

CIP-Wastewater Utility Fund

PURPOSE:

Award bid (construction contract 500388) for the Mulberry Wastewater Treatment Plant (WWTP) Aeration Basin, Structural and Motor Control Center (MCC) Upgrades Project in accordance with City Code §§ 3.10.010.2 (A.R.S. Title 34) and 3.10.030.1.

BACKGROUND:

The Mulberry Wastewater Treatment Plant contains two circular aeration basins that contain equipment mounted onto bridges that rotate around each basin mixing the wastewater. Each basin is approximately 126 feet in diameter and 16 feet high. Cracking on top of the basin, as a result of the weight of the bridges, began to show up approximately two years ago and a structural engineer was brought in to assess and propose a fix.

As a result of that evaluation, plans and specs were generated with a solution of filling the cracks and placing a steel cap all around the top of each basin. Seeing an opportunity to upgrade the dilapidated Motor Control Center, a design was incorporated for replacing that at the same time. On July 26, 2023, sealed bids were opened for the project and five (5) bids were received in response. The five responsive bidders were:

Technology Construction, Inc. -

FISCAL IMPACT:

Funds in the amount of \$1,297,964 are available in the Fiscal Year 2023-24 Capital Improvement Plan budget using Wastewater Utility Funds.
