**PURPOSE:**

Award bid for the Construction Contract 500392 to Perco Rock Company for the Wash Crossing Improvements El Dorado Avenue N., in accordance with City Code §§ 3.10.10.2 (A.R.S. Title 34) and 3.10.030.1.

**BACKGROUND:**

This project was identified to improve wash crossing safety during storm events by elimination of the At-Grade crossing of El Dorado Avenue North at the El Dorado Wash with multiple box structure design.

The project was bid to construct a multiple box wash structure to create a roadway crossing during the 100-year storm event.

On September 11, 2023, sealed bids were opened for the project and four (4) bids were received in response.

The Lowest responsive bidder is:

Perco Rock Company      Base Bid: \$1,988,760

**COMMUNITY IMPACT:**

This project will provide a safer wash crossing with drainage improvements and roadway sight distance improvements.

**FISCAL IMPACT:**

Funds are available in the Fiscal Year 2023-24 Capital Improvement Plan using Flood Control Funds in the amount of \$2,125,000.

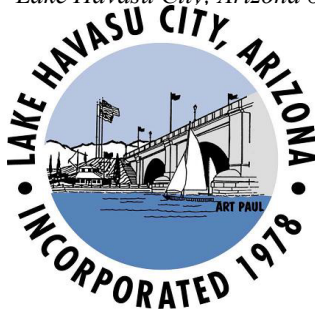
