Award Bid to ASR Construction Group, LLC, for Booster Station 5A Improvements (*Jarod Thiele*)

**FUNDING SOURCE:**

Water Fund

**PURPOSE:**

Award bid for Contract 500354 to ASR Construction Group, LLC, in the amount of \$2,299,921 for Booster Station 5A Improvements in accordance with City Code Section § 3.10.030.

**BACKGROUND:**

Due to the age of existing Booster Station 5A, a Capital Improvement Project (CIP) was created to design and upgrade the current system. Following the completion of final design, bid documents were released. This project includes the replacement of pumps, valves, and piping and other appurtenances.

Bids for the Booster Station 5A Improvements Project were opened on April 12, 2023, at which time six (6) bids were received. Upon review of the bids, it was determined that ASR Construction Group, LLC, is the apparent low bidder for this project.

**COMMUNITY IMPACT:**

This project will improve the existing infrastructure to continue the ability to provide potable water to the community and eliminate a potential failure in the City's water system.

**FISCAL IMPACT:**

Funds are allocated in the CIP budget for Fiscal Year 2023-24 for this project.
