Award Bid for Fiscal Year 2023-24 Crack Seal Program to Holbrook Asphalt Company (*Bill Young*)

FUNDING SOURCE:

Highway User Revenue Fund (HURF)

PURPOSE:

Award bid for Fiscal Year (FY) 2023-24 Crack Seal Program (Project SM313N-500389) in accordance with City Code §§ 3.10.010.2 (A.R.S. Title 34) and 3.10.303.1.

BACKGROUND:

Lake Havasu City maintains its roadways with standard maintenance practices, including the crack sealing of those roadways scheduled for future chip seal or asphalt concrete pavement in need of this treatment. Cracks form in pavement due to expanding and contracting caused by hot and cold temperatures. Crack sealing prevents water infiltration, improving the lifespan of the pavement.

Approximately 1,000,000 square yards will be treated this year, this is the equivalent of approximately 150 lane miles of roadways and 13% of the city's parking/walking paths, or about 12% of the city's total assets.

There were seven (7) bids submitted for this work, ranging from the low bid from Holbrook Asphalt Company of \$749,116 to a high bid of \$1,655,700.

COMMUNITY IMPACT:

By contracting out this work, the City maximizes the efficiency and effectiveness of the community's resources. Crack sealing extends the life of the roadways and maximizes the community's return on investment.

FISCAL IMPACT:

Funds are available in the Highway User Revenue Fund (HURF) for Fiscal Year 2023-24.
