Award Airport Automated Weather Observation System (AWOS) Upgrade Project to Pavex Corporation
(Jarod Thiele)

FUNDING SOURCE:

CIP-Grant and a match from the Airport Fund (transfer from General Fund)

Funds in the amount of \$315,000 were allocated through the Arizona Department of Transportation (ADOT) grant awarded to the City for this project, which included a City match of \$31,500. \$60,000 was allocated for design in the prior fiscal year, the remaining \$255,000 is available for this project.

PURPOSE:

Award the bid for the Airport Automated Weather Observation System (AWOS) Upgrade Project, Contract 500408, to Pavex Corporation, in accordance with City Code § 3.10.010.2 (A.R.S. Title 34) and 3.10.030.1. The current AWOS system at the Airport has passed its useful life and needs upgrading. This system is required by the Federal Aviation Administration to measure current weather conditions at the Airport including barometric pressure, wind speeds, temperature, and runway surface conditions. To ensure the safety of planes landing, it needs upgrades.

BACKGROUND:

On March 14, 2023, City Council awarded Task Order No. 4 to the Master Services Agreement to C&S Companies for design and construction management services for this project. Design was completed and bids were released and received until September 13, 2023, at which time they were opened. A total of three (3) bids were received with Pavex Corporation being the lowest responsive and responsible bid in the amount of \$211,030.

COMMUNITY IMPACT:

Lake Havasu City Airport is a vital economic and transportation hub in our community. It plays a significant role in the local economy as well as bringing in many work-related visitors (military and civilian training).

FISCAL IMPACT:

Funds in the amount of \$255,000 are available through the ADOT grant awarded to the City for this project plus the City match of \$25,500 in the Capital Improvement Plan. Since the project came in under budget, less grant funds and City match will be required.
