Award Bid for the London Bridge Pier D Repair Re-Bid Project to Restruction, a Division of Structural Preservation Systems, LLC (*Jason Hart*)

FUNDING SOURCE:

CIP-HURF Funds

PURPOSE:

Award bid for the London Bridge Pier D Repair Re-Bid Project in accordance with City Code §§ 3.10.010.2 (A.R.S. Title 34) and 3.10.030.1.

BACKGROUND:

The London Bridge is a vital link of the mainland of Lake Havasu City to the island that falls within the City limits and home to many citizens. Originally constructed from 1967 to 1971, it has served well the citizens of Lake Havasu City and the millions of visitors that have flocked to the city to see Arizona's second major tourist attraction. Until recent years the four piers that the arch bridge rests upon have experienced little to no issues. However, Pier D began to take on water with two attempts being made over the last ten years to drain and fix the apparent leakage to prevent corrosion of the bearing pad within the pier. In the last three bridge inspection reports performed by ADOT they have noted this and requested a repair be done.

The City hired Kimley-Horn & Associates in January of this year to perform an assessment of the pier and provide recommendations of how best to fix the pier leak. A solution was developed and plans and specs were created to solicitate bids from contractors who specialize in this type of work.

On July 26, 2023, sealed bids were opened for the project and one (1) bid was received in response. The responsive bidder was:

Restruction, A Division of Structural Preservation Systems, LLC.

- Base Bid + Force Account = \$372,879

COMMUNITY IMPACT:

This construction of this repair project to the London Bridge Pier D will help preserve the pier from future deterioration and keep access to island for City residents.

FISCAL IMPACT:

Funds in the amount of \$372,879 are available in the Fiscal Year 2023-24 Capital Improvement Plan budget using Highway User Revenue Funds.

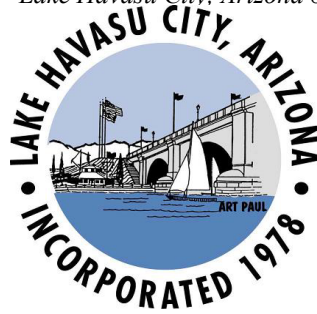
