PURPOSE:

To consider approval of the License and Use Agreement for Lake Havasu City Municipal Airport Hangar 59 with Zephyr Systems, Inc.

BACKGROUND:

On September 18, 2024, Lake Havasu City released a Request for Proposal (RFP) for qualified parties to develop and operate an aircraft maintenance facility as a Special Aviation Service Operator (SASO) in an available City-owned hangar. Three proposals were received and evaluated by a panel in accordance with the RFP requirements and criteria and resulted in a recommendation for the selection of Zephyr Systems, Inc.

COMMUNITY IMPACT:

This facility will add much-needed additional maintenance capability at the Airport focused primarily on smaller, piston-driven general aviation aircraft.

FISCAL IMPACT:

This agreement will produce revenue for the Airport Fund. This agreement has the potential to generate more than \$100,000 over three years or almost three times the \$35,136 generated collecting a single user lease payment over the same amount of time.
