**RFP DESCRIPTION:** Lake Havasu City is seeking to identify one qualified party interested in leasing a parcel of land of up to 4 acres, named the North Central Ramp Area, for aeronautical use at the Lake Havasu City Airport. The City is looking for a proposal that provides both maximum revenue and meets aeronautical needs for the City's Airport.
