***SPECIAL REQUIREMENTS FOR BRUSHING*(LINE 27)**

Contractor Shall use a Spiral design type brush making 360 degrees contact of well inside diameter.

Contractor shall use a "Spudder Type Rig" with walking beam for brushing and bailing well.

NOTE: It is the intent of the City to award each project separately. Your firm does NOT need to bid on all projects to be considered for any of the projects.

The unit prices for **Well Maintenance Projects REBID, B25-PW-500576**, shall include all labor, materials, water disposal, bailing, shoring, removal, disposal, overhead, profit, insurance, and all other related costs and work to cover the finished work of the several kinds called for. Changes in the Contract shall be processed in accordance with Paragraph 16 of the General Conditions.

Bidder understands that the Owner reserves the right to reject any or all Bids, or portions thereof, and to waive any informalities in the bidding. **Owner also reserves the right to award each Phase separately if it is in its best interests.**

The Bidder agrees that this Bid shall be good and may not be withdrawn for a period of ninety (90) calendar days after the scheduled closing time for receiving Bids.

Upon receipt of written notice of the acceptance of this Bid, Bidder shall execute the formal Contract attached within 10 days and deliver a Performance Bond, Payment Bond, and Certificates of Insurance as required by Paragraph 25 of the General Conditions and the Special Provisions.

The Bid security attached in the sum of \$_____ is to become the property of the Owner in the event the Contract and Bond(s) are not executed and provided within the time above set forth, as liquidated damages for the delay and additional expense to the Owner caused thereby.
