This month's TPT Collection Report includes all collections through February (merchant collections through January 2023). Arizona Department of Revenue provides tax collection information.

Fiscal Year to Date (FYTD) TPT collection is 1.3% or \$278,271 above budget and 2.6% above the prior year for the same reporting period. The February month-over-month is a -.3% or \$8,400 decrease. February was also -7.2% or \$229,677 less than the budget.



February year-over-year TPT collection increased in Restaurants and Construction. There was a decrease in Accommodations, Rentals, Retail, and Use Tax, with the largest decrease of \$20,799 in retail. The restaurant increased \$41,106 or 8.2%, Construction increased \$15,296 or 4.9%.



Accommodations and Restaurant & Bar

Lake Havasu City collects an additional tax on accommodations (3%) and restaurant & bar sales (1%). The revenues generated by these additional taxes support tourism and economic development. The Partnership of Economic Development (PED) receives \$500,000 annually, and the Convention & Visitor's Bureau (Go Lake Havasu) receives \$1.6 million annually.
