This month's TPT Collection Report includes all collections through May (merchant collections through April 2023). Arizona Department of Revenue provides tax collection information.

Fiscal Year to Date (FYTD) TPT collection is -1.2% or \$390,953 below budget and -0.6% or \$192,101 below the prior year for the same reporting period. The May month-over-month is a -7.0% or \$264,156 decrease. May was also -0.4% or \$12,658 less than the budget.



May year-over-year TPT collection decreased overall, with the most significant dollar impact being in Construction, Retail, Use Tax, and Accommodations. Construction decreased \$134,001 or 35.7%, Retail decreased by \$65,062 or 3.5%, Accommodations decreased by \$40,694 or 9.4%, and Use Tax decreased by \$61,607 or 39.0%. The only increases were in Communication and Restaurants/bars. Communication increased by \$18,572 or 32.1%, and Restaurants/Bars by \$27,389 or 4.8%

#### **Accommodations and Restaurant & Bar**

Lake Havasu City collects an additional tax on accommodations (3%) and restaurant & bar sales (1%). The revenues generated by these additional taxes support tourism and economic development. The Partnership of Economic Development (PED) receives \$500,000 annually, and the Convention & Visitor's Bureau (Go Lake Havasu) receives \$1.6 million annually.
