Transaction Privilege Tax (TPT) Collections Report

September 2025



This month's TPT Collection Report includes all collections through September (merchant collections through August 2025). The Arizona Department of Revenue provides tax collection information.

Sales tax revenues for September 2025 totaled \$2.8 million, down 7.1% from September 2024's \$3.0 million. Overall, FY2026 revenues are tracking closely with the prior year and slightly below budget expectations.



Year-to-date revenues total \$6.18 million, essentially flat (-0.25%) compared to \$6.20 million for the same period last year and 4.7% under budget. The September decline was broad-based, led by Construction and Utilities, and partially offset by gains in Restaurants and continued strength in Retail. For September, Restaurants and Bars increased 5.9%, Retail decreased 0.2%, though online marketplace sales continued to provide stability. Accommodations were nearly flat (-0.1%), and Construction dropped 29.9%. Use Tax was a negative \$98,577, due to a prior-year refund adjustment.






The high growth in FY21 is due to the influx of visitors from neighboring states with stricter COVID restrictions.







Accommodations Plus Restaurant and Bar

Lake Havasu City collects a tax on Accommodations of 3.0% and Restaurant and Bar sales of 1.0%. The revenues generated support tourism and economic development. The Partnership of Economic Development (PED) receives \$500,000 annually, and Go Lake Havasu receives \$1.6 million annually.
