The Lake Havasu City Sales, Use and Accommodation Tax Report examines taxes collected during the month of July 2020 by businesses and vendors, which were reported and remitted to the Arizona Department of Revenue in August 2020. Tax collection information is provided by Arizona Department of Revenue.

Sales Tax

Fiscal Year to Date (FYTD) August 2020 sales tax collections are 66.0% above budget and 22.0% above prior year. The month of August is 25.9% above prior year.





Retail Sales

August retail sales tax collections have Increased by \$340,629 or 31.4% compared to the same period last year. Fiscal Year to Date collections are 28.7% higher than last year. Note that the Wayfair case - requiring out-of-state online retailers to remit Arizona TPT taxes went into effect 10-1-2019.


