CONDITIONS OF USE :

- Applicant will be responsible for turning on lights at Island Ballfield; all other lights will be controlled through Aquatic/Recreation Division.
- Applicant will required to pick up all debris and litter from permitted area.
- Applicant will provide a 24 hour notice of any change in permitted use, including cancellations and time changes.
- Ballfields will not be used if fields are wet and footprints are visible in wet dirt when walked on.
- Buildings & Grounds Division will be responsible for dragging of fields.
- Individual groups may take responsibility for the lining of their own fields.
- Building & Grounds Division will be notified at 855-1851 of any damage incurred to the field or park facilities.

Failure to follow any of the above use conditions will result in loss of use of park facility

Applicant agrees to indemnify, defend, save, and hold harmless Lake Havasu City, including its departments, agencies, boards, commissions, officers, officials, agents, volunteers, and employees, from and against all claims, actions, liabilities, damages, losses, or expenses (including court costs, attorney's' fees, and costs of claim processing, investigation and litigation) (hereinafter referred to as "Claims") for bodily injury or personal injury (including death) , or loss or damage to tangible or intangible property caused, or alleged to be caused, in whole or in part, by the negligent or willful acts or omissions of Applicant or any of its owners, officers, directors, agents, volunteers, employees, invitees, or contractors, arising out of or related to Applicant's occupancy or use of City facilities, property, or equipment, except for Claims arising solely from the negligent or willful acts or omissions of the City. It is agreed the Applicant will be responsible for primary loss investigation, defense, and judgment costs where this indemnification is applicable

LAKE HAVASU CITY WELCOMES YOU

We want to make your use of the park a pleasurable one. To avoid any misunderstanding please take a moment to review the following simple rules and regulations.

- This permit shall remain in effect only during the date and time shown on this permit
- This permit is non-transferable
- Permit holder shall retain a copy of the permit and have in his/her possession the day of use
- Permit shall be shown upon request by any city official
- All activities specified or permitted under this permit shall be conducted under appropriate adult supervision
- Permit holder shall be responsible for clean-up and restoration of the area used by permittee and shall be fiscally responsible for any damage incurred during use
- Permit holder shall be responsible for all members of his/her group and shall ensure that all park rules and regulations, state laws and all other provisions of this permit are met

General Park Rules:

- NO ALCOHOL allowed in the park without signed Park Use Permit
- NO GLASS CONTAINERS allowed in any city park
- NO CAMPFIRES allowed except in barbeques or approved containers
- NO DOGS or PETS allowed in Rotary Community Park
- NO LAUNCHING or RETRIEVING of any watercraft from beach
- NO TRAILERS allowed in the park
- NO MOTORHOMES other than Park Host's allowed in the park
- NO OVERNIGHT MOORING on the beach
- NO BOUNCE HOUSES or SLIP-IN SLIDES on grass areas

No person shall sell or offer for sale any food, wares or merchandise in the park without written permission by the Department Director.

Motorized vehicles must remain on maintained roadways, parking areas and areas designated by signs for vehicle use.

All parking is on a first come, first served basis; we do not reserve parking spaces.

The City parks have been improved for your enjoyment. We ask for your assistance in keeping them clean and safe for everyone's use.
