A Tent Construction Permit is required if erecting an air-supported temporary membrane structure or a tent with an area in excess of **400 square feet**. Exceptions are listed on the **Lake Havasu City Fire Department Specification #11, Standards for Tents and Other Membrane Structures** (available online at <https://www.lhcaz.gov/fire-department/fire-code>). Other applicable requirements are contained in the **International Fire Code**. **Permits shall be applied for by the vendor erecting the tent(s) or the promoter of the event.**
