This Month in Military History



December 7, 1941 - "A date which will live in infamy"

During World War II, President Franklin D. Roosevelt and the United States maintained a policy of non-intervention, focusing on peace through isolation and disarmament, similar to the Good Neighbor Policy in Latin America. However, this stance quickly changed on December 7, 1941.

On this day 84 years ago, the Imperial Japanese Navy Air Service launched an aerial attack on Naval Station Pearl Harbor resulting in the deaths of 2,403 service members and civilians. A further 1,178 people were injured and two U.S. Navy battleships, the USS Arizona and the USS Utah, were permanently sunk. Ultimately, this attack led to the United States' involvement in the War as an official member of the Allies.

Each year on December 7, the Pearl Harbor National Memorial in Hawaii hosts a series of events commemorating and honoring the injured and fallen service members and civilians. For more information, please visit <https://pearlharborevents.com/description-of-events>

In Lake Havasu City, our Marine Corps League Detachment #757 is currently raising funds for a USS Arizona Memorial to be located on the south end of London Bridge Beach. At the center of the memorial will be a 4ftx6ft, 520lbs relic of the USS Arizona. The memorial will serve as a place to honor and remember the injured and fallen, and all those who served.

BIOGRAPHY

Judge Mitchell Kalauli served in the Utah Army National Guard from 1987 to 1993, deploying to Germany during Operation Desert Shield/Desert Storm in 1991. After returning from active duty, he received a bachelor's degree in psychology in 1993 and a Juris Doctor degree in 1997. Judge Kalauli practiced immigration law and civil litigation for 5 years in Seattle, Washington, before becoming the Moccasin Precinct Justice of the Peace, Chief Judge for Kaibab Paiute Tribe, and City Magistrate for the Towns of Colorado City and Fredonia in Northern Arizona in 2004. He is a current member of the Arizona State Bar and has been the Magistrate for Lake Havasu City since May of 2011.

In 2013, Judge Kalauli was instrumental in the establishment of the Lake Havasu City Veterans Treatment Court, the first rural VTC in Arizona. Believing in its success, he worked with the cities of Kingman and Bullhead City and La Paz County to establish their own Veterans Treatment Courts. He has presented about Veterans Treatment Courts at the All Rise National Treatment Court Conference in Washington DC and assisted in the establishment of the Lake Havasu City Veteran's Resource Team. He was inducted into the Arizona Veterans Hall of Fame Society in 2017 and received the VVA National Achievement medal for his work with Justice-Involved Veterans.

Judge Kalauli and his wife Nickie have 37 children (actually, only 6 children, a daughter-in-law, a perfect granddaughter, and 3 dogs). He loves to coach his children in any sport they play (except soccer) and is currently the freshman boys' basketball coach at the high school. He is active in his church and is currently assigned to oversee congregations in Needles, Lake Havasu City, Parker, Quartzsite, and Blythe. He works with and for the best people in the world and is grateful to be a part of the Lake Havasu City Veterans Treatment Court Team. 'Ohana!

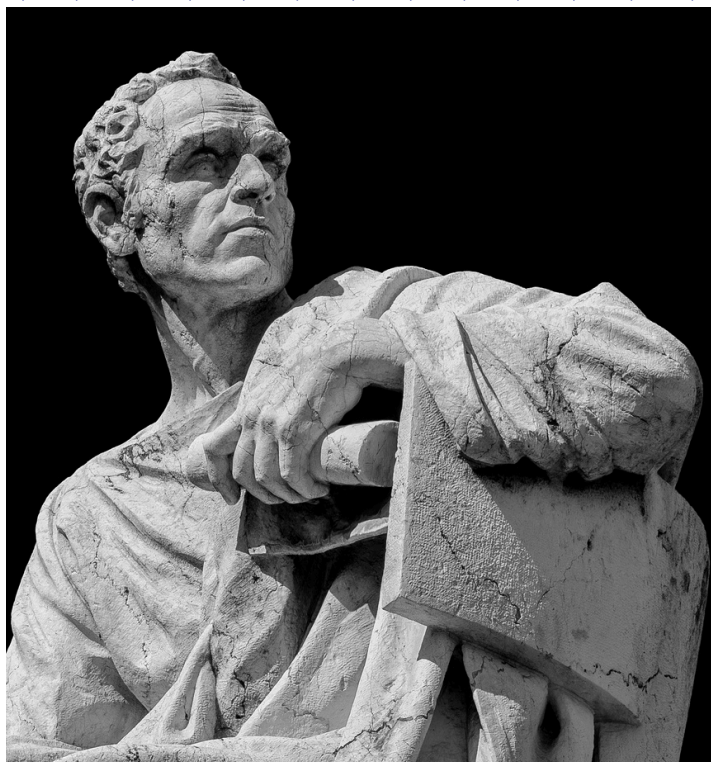
