# This Month in Military History



## February 12, 1973 - Operation Homecoming Begins

Following the Paris Peace Accords, which ended the United States' involvement in the Vietnam War, *Operation Homecoming* began its first mission. Henry Kissinger, then assistant to President Nixon for National Security Affairs, agreed to a ceasefire with representatives from North Vietnam. Part of the agreement called for the release of nearly 600 American prisoners of war (POWs) from North Vietnam within 60 days of the withdrawal of U.S. troops.

Starting on February 12, 1973, over 50 C-141 missions flew out of Hanoi, transporting former POWs home to the United States. **591** former POWs returned to the United States, some spending nearly a decade in Viet Cong and People's Army of Vietnam prison camps. Notably, late Arizona Senator, John McCain, was a POW in Hanoi from 1967 to 1973 after his plane was shot down in Operation Rolling Thunder. Despite years of torture, McCain refused an out-of-sequence release from the prison camp, then continued his service in the Navy for 8 more years. Following initial egress flights, former POWs were slowly repatriated, receiving medical care and wide-spread media attention.

While there is no official holiday specifically commemorating the historic operation, February 12 serves as a time of remembrance for the return of Vietnam POWs and an acknowledgement of their service and sacrifice. In 2023, the United States commemorated the 50<sup>th</sup> anniversary of Operation Homecoming by flying a C-17 to Hanoi as a symbol of the first flights of the operation. The event emphasized the bravery the former POWs embodied, as well as their resilience and camaraderie.

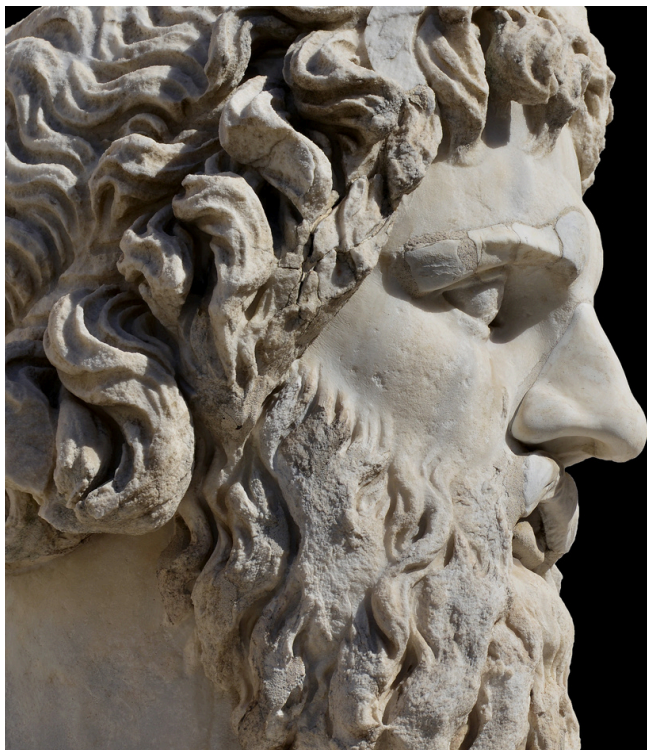
