

This Month in Military History



March 26, 1945 - The Battle of Iwo Jima is WON by American Forces!

A strategically critical air base for Japanese fighter planes, the island of Iwo Jima, was finally captured on March 26, 1945, after five weeks of heavy fighting and casualties.

Initially, the Imperial Japanese Army used Iwo Jima as a staging area and air base to intercept U.S. long-range B-29 Superfortress bombers. The capture and control of Iwo Jima was critical in securing air and sea superiority in the Pacific theater for the United States.

In total, 6,871 U.S. service members were killed and 19,217 were wounded in the battle. As Admiral Chester W. Nimitz reflected, “Uncommon valor was a common virtue” among the Sailors and Marines who secured the island. 22 Marines and 5 Sailors were awarded the Medal of Honor for their efforts and sacrifices during the Battle.

For most, the Battle of Iwo Jima invokes the image of the flag being raised on Mount Suribachi. On February 23, Marines from 2/28 Marines were sent on a reconnaissance mission to observe the mountain’s north face, expecting ambushes along the way. After a few moments of contact, it was concluded that the enemy forces were primarily using the vast tunnel systems throughout the island. This reconnaissance mission allowed six Marines to crest Mount Suribachi and plant the U.S. flag. The image instantly became famous and one of the most circulated images of the war during that time. Just one month later, the United States would fully and successfully gain control of the island, thus ending the Battle of Iwo Jima.
